Candidates will be engaged on a Fixed Term Contract initially for a period of 5 years.

- a. A recent (not more than 3 months old) coloured passport size photograph of the full face (front view) should be pasted neatly in the space provided in the Application Form.
- b. For candidates belonging to OBC category, the category certificate should be in the prescribed format including the Non-Creamy layer Clause issued by the Competent Authority for employment under Government of India and should be as per the Central list of OBC's published by the Govt. of India. Please also note that the validity of Non-Creamy layer Certificate should not be older than 6(six) months from the date of eligibility criteria.
- c. Applicants working in Government/Semi-Government/Public Sector Undertakings or autonomous bodies, must come with the complete Application Form routed through proper channel or along with No Objection Certificate from their present Employer.
- d. The short listed candidates will be considered for engagement on a fixed term Contract basis, subject to their Medical fitness, cost of which have to be borne by the candidate, prescribed for the position.
- e. For the process of Interview, candidates may be required to stay back for a day or two at their own expenses, if required. No reimbursement shall be made in this regard.
